

## PRODUCT DATA SHEET

### Q4™

#### Heavy Duty Solvent Degreaser

##### SUITABILITY:

- For the effective removal of heavy soiling from substrates such as tiles, concrete, pavers, workshop floors, machinery, fabric and carpets, etc.
- For the removal of bitumen and pencil marks.
- For the removal of lipstick, crayon, make-up, pen, paint, etc.
- Not suitable for marble, enamels, aluminium and delicate surfaces.
- Do not apply to painted, varnished or oiled surfaces.
- Test small area for suitability of product first.

##### APPLICATION:

- For vertical surfaces add 50ml water to 1 liter of Q 4™. Allow to thicken. Apply by cloth or brush and allow it to “hang”. Scrub with a natural or synthetic brush working the solution of Q 4™. Rinse with clean water.
- Dab off carpets with a soft cloth. Wash off very well with copious amounts of clean water.
- For horizontal surfaces with heavy oil, grease or bitumen soiling, treat as above.
- For medium to light oil, grease etc soiling on tiles, concrete, pavers etc, dilute Q 4™ degreaser detergent 1:5 with clean water.
- Apply by mop or broom and allow time for the Q 4™ to react.
- Test a small section to determine when ready and scrub the area vigorously.
- Rinse off with clean water. Repeat if necessary.
- Q 4™ is highly dilutable. Assess required dilution by testing on site.

##### SAFETY:

- Use eye protection, rubber gloves and chemical resistant safety shoes
- Do not wear rubber soled shoes
- Use respiratory masks with organic filters ensuring area is well ventilated
- Rinse eyes and skin with copious amounts of clean water
- Apply fatty based cream to skin
- Do not induce vomiting. Seek medical attention
- Contains toluene

##### FIRE:

- Foam, dry powder, CO2
- Class Flammable III

##### SPILLS:

- Soak up with absorbency material and dispose at a suitable disposal facility

##### COLOUR:

- Undiluted - green, Diluted - milky white
